BUSINESS LICENSE APPLICATION

Compliance with the Walker River Paiute Tribal Taxation Code Title 20 regulations is essential to ensure smooth operations. The included application forms are mandatory for businesses seeking to obtain a Walker River Paiute Tribe Business License. It is highly recommended that these forms be meticulously reviewed and accurately completed to avoid any delays or disruptions in the licensing process. Should you have any questions or concerns that remain unanswered by the forms, please do not hesitate to contact the Tax Department. Their team of experts is readily available to provide you with the necessary guidance and assistance to ensure the successful completion of the application process.

- A license fee shall be paid before any license is issued.
- Annual Business License shall be valid for one (1) year from the date of issuance.
- Temporary Business License shall be valid for three (3) months from the date of issuance.
- Peddler's permit shall be valid for one (1) day only.
- All Business Licensees are responsible for renewing their Business License before the date of expiration.
- Any person doing business on the Reservation without a Business License or fails to renew a Business License as provided for, shall immediately obtain a Business License and pay the required fees, and/or be fined \$50.00 per day for each day it operates on the Reservation without a license, unless good cause is shown to the Tax Department as to why such a license had not been obtained within a timely manner.
